<u>Regular Meeting – Establish Quorum:</u> The following board members were in attendance and a quorum was established.

<u>Business Operations Report</u> - Sheila Baker gave the year end report.

General Fund – For the month of November Expenditures were over Revenue received by \$357,509.

Year to Date: Revenue is \$5,279,178 (22.5% of Budgeted) and Expenditures are \$6,292,114. (28.2% of Budgeted). Expenditures over Revenue for the year is \$1,045,982. As a reminder, November is the month where we only receive 5% of the apportionment total and we are still receiving apportionment based on budgeted enrollment. January is when we start receiving apportionment based on actual enrollment numbers.

Fund Balance in all funds:

General Fund: \$874,576.

Cap Project - \$76,017.

Debt Service Fund - \$1,405,190. (Bond Payments were made Dec 1 st. in the amount of \$1,116,220)

ASB Fund - \$259,711.

Transportation Vehicle Fund - \$188,829.

Enrollment: Our December FTE was 1,406.85 We lost just .84 FTE from November. Our Annual Average Enrollment is 1,408.18 which is just over 47 FTE higher than budgeted. As a comparison, this time last year our Annual Average Enrollment was 1,357.47 This is an increase of 50 FTE (Mostly due to Transitional Kindergarten).

Other Information:

You probably had noticed that we have a Warrant listed from the Private Purpose Trust Fund. At the Auditors recommendation, we are accounting for all Foodbowl Revenue and



Expenditures in this Fund. The auditor is defining this activity under the rules of "Custodial Funds" and because of the amount of this activity it should be accounted for in Fund 70 instead of in the ASB fund as in previous years. In the past this fund has been used strictly for student scholarships.
